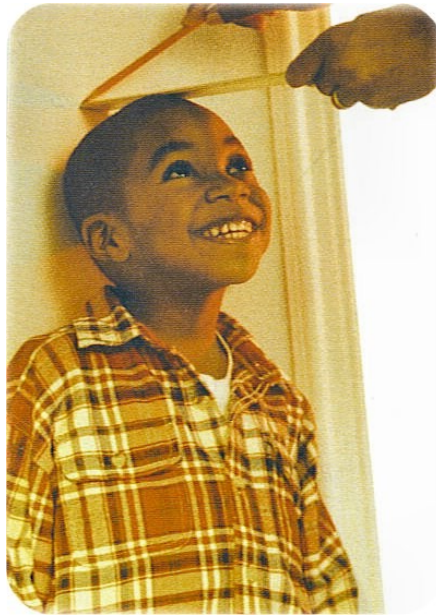

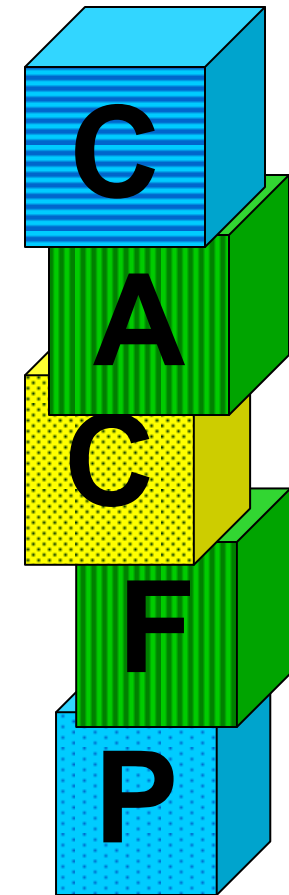

---

**It's good for the children, providers, and parents.**

## CHILDREN WILL...

- ◆ Receive nutritious meals and snacks
- ◆ Develop good eating habits
- ◆ Develop fit bodies, strong teeth, and alert minds

## PROVIDERS WILL. . .

- ◆ Receive current information on good nutrition, health and fitness
- ◆ Get menu ideas and recipes
- ◆ Receive a monthly check to help cover food costs
- ◆ Have opportunities to attend nutrition training sessions
- ◆ Receive one-on-one program training



## PARENTS WILL. . .

- ◆ Be assured that their children are eating healthy meals and snacks at no extra charge to them
- ◆ Receive nutrition information

## What is this



## What is this program?

The Child and Adult Care Food Program (CACFP) provides child care operators with nutrition education and financial reimbursement for part of the cost of meals served to children in their care. It is funded by the US Department of Agriculture (USDA).

---

## Who can participate?

All **family child care homes** and **centers** licensed with the State of NC are eligible.

---

## What is required to participate?

- ◆ Providers must serve USDA approved snacks and meals
- ◆ Daily record keeping on foods served and number of children in attendance



In Addition.....

- ◆ No special kitchen equipment is required
- ◆ No special foods must be purchased
- ◆ Approved meals consist of wholesome foods that most providers are probably already serving.
- ◆ Free software will be provided for those wanting to go paperless for daily record keeping



## How much is the monthly check?

Reimbursement is based on the number of meals served and the number of children in attendance. In some cases the provider's own children may be included in the reimbursement.
